FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Rig up and displace well fluid with mud, spot cement plug up to 50 ft. above pers. 9640' to 9730', pull tubing. Shoot and pull 5 1/2" casing, run tubing spot 100' plug (50' in & out) of 8 5/8" casing (4050' to 4150') pull tubing, shoot and pull 8 5/8" casing. Run tubing, spot 100' plug (50' in & out) of 13 3/8" casing (380' to 480') pull tubing. Spot 5 sk cement plug at surface. Weld plate and marker on 13 3/8" casing. Will shoot 8 5/8" casing at approximately 1400', and 5 1/2" casing at approx. 8000'.
