On 6-7-60 ran and cemented 248 fts 5 1/2" OD casing (9710.73) - 22 fts. J&L, 17#, 716.62; 116 fts. Republic, 15.5#, 4787.03; 40 fts. J&L, 17#, 1480.13; and 70 fts. Republic, 17#, 2726.95. Pipe seated at 9740', and cemented with 225 sacks bulk cement, 4% gel. Eight Baker hinge lock scratchers spaced 15' apart from 9735' to 9630'. Seven Baker single rigid centralizers spaced 1 ft. apart from 9738 to 9540'. Tested 5 1/2" casing, 30 min. o.k. W.O.C. 24 hours. Tested 5 1/2" casing at 1500#.


