Mixed 34 sx 12% gel cmt. containing 180# Gilsonite, displaced cmt. opposite perforations from 12890-12710'. Max. press. 700 PSI. Unable to obtain squeeze. Cleared perforations. Mixed 34 sx. 12% gel cmt. containing 180# Gilsonite. Spotted cmt. across perforations 12710-12890. Squeezed 3 sx into form. Max. press. 3000 PSI. Reversed out 31 sx. Closed type "A" slide door in tbg. at 12626'. Ran collar stop @ 9025'. Acid washed w/ 5 batches of 250 gals. each. Perf. csg. 12857-12861 w/ 2 capable shots per ft. Set tbg. stop at 12589 w/ Otis wire line. Swabbed well recovering nearly 100% water. Killed well. Squeeze cemented perf. 12710-12800 w/ 75 sx. neat cmt. Max p.ress. 3500#, Final Press. 3000#. Reversed out 20 sx. Pulled tbg. Perforated 7" csg. from 9884-9900' w/ 2 jet shots per ft. Set Baker prod. packer on wire line at 9800'. Ran 2" tbg. & set at 9800'. On 15.5 hr. flow test produced 172 bbls. oil. 11/64" choke. Corr. grav. 49.5, TP 875#. G.s 294 Mcf/day. GOR 1105. Flowing oil well thru perforations from 9884-9900'.
