DETAILS OF WORK

Rigged up Bateman & Whitsitt & installed BOP. Ran 2" tbg. open ended to 9623'. Displace water with mud. B J Service, Inc. spotted 75 sx cement through tbg. Top cement @ 9023' (Calc.). Pulled tbg. to 3900'. B J Service, Inc. spotted 20 sx cement. Top cement calculated @ 3799'. McIlhenny Trucking Co. cut off well head & dumped cement plug surface to 13'. Mud laden fluid between plugs. Installed regulation monument. Plugged & Abandoned 7/16/61.
