In accordance with Form 9-331e dated April 3, 1964, re-entry of hole was made, work performed and well completed as follows:

"Drilled plugs and cleaned out to 4900'. Set cast iron bridge plug at 4900' and pressure tested casing with 1500 PSI. Test OK. Perforated 5-1/2" casing at 4856' and squeezed behind with 100 sx cement. Ran collar log and perforated interval 4825'-30' W/2 SPF, acidized with 7000 gallons. No oil or gas. Covered perfs with sand (sand 4806'-4840' PBD) Perforated 4768'-90' W/2 SPF. Acidized W/7000 gallons. Fraced with 30,000 gal water and 27,000# sand and 3,000# glass beads.

Scabbed in and evaluated.

On Test well flowed at rate of 445 MCFPD, 48 BW, trace of oil in 24 hours. TPF 425, 18/64" choke. SI for PL connection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
