FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Well was drilled to 10,549' total depth without encountering commercial shows of oil or gas. Plugging will be by mud and cement plugs at the following depths: 20 sacks from 10,549' to 10,480', 10 sacks from 10,211' to 10,177', 15 sacks from 10,115' to 10,063', 10 sacks from 5670' to 5636', and 20 sacks from 4264' to 4195'. The 8-5/8" intermediate casing will be cut and pulled from approximately 1500', after which 10 sacks of cement will be placed in the top of the remaining 8-5/8" casing, 10 sacks at the bottom of the surface casing, and 10 sacks in the top of the surface casing.
