Total depth drilled 13228'. Plug back depth 9450'. Plugged well by placing cement plugs of 55 sacks from 9200' to 9000', 75 sacks from 5400' to 5200', 80 sacks from 4327' to 4127', and 80 sacks from 200' to surface. Installed regulation marker. Cut 5-1/2" casing at 9100' and recovered 9088'.
