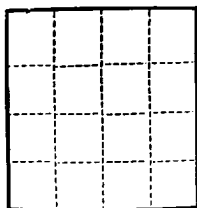

Proposed Program:

1. Use rotary tools from surface to total depth. Set 13 3/8" 48# casing at 350' and cement to surface.
2. Set 8 5/8" 32# casing at 4200' and cement to top of salt section.
3. Set 4 1/2", 9.5# & 11.6# casing through Bough "C" pay zone and cement with 200 sacks.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

4. Run Radioactivity logs & perforate pay.

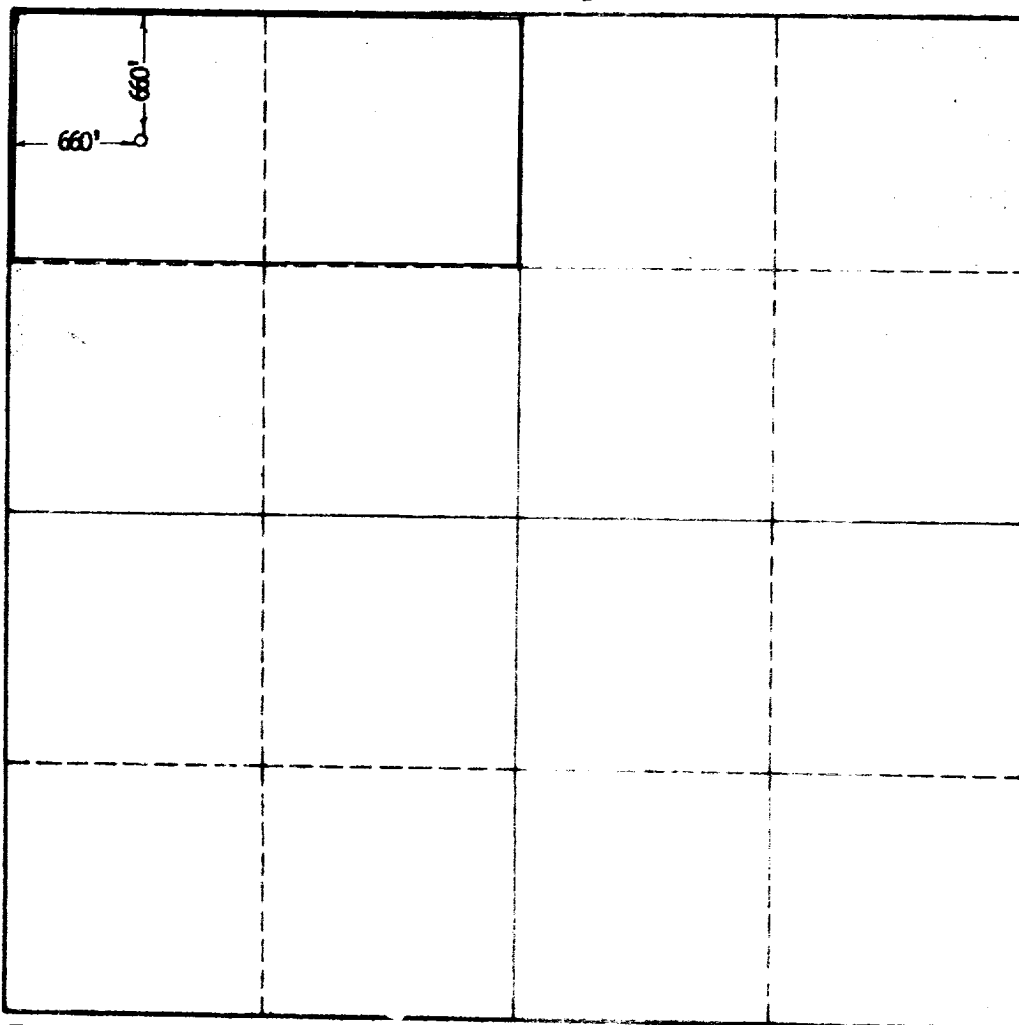
