

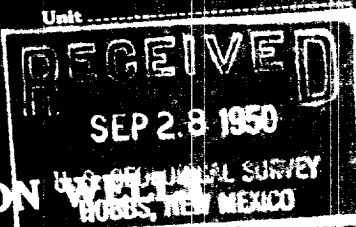

Objective - Limestone of Wolfcamp age which produces in the Bough Field.
Approximate depth 9725 feet.

Casing Program - 13 3/8" O.D. 48# 375 ft. 400 sxs. cement.
8 5/8" O.D. 32# 4300 ft. 2300 sxs. cement.
5 1/2" O.D. 17# 9800 ft. 1500 sxs. cement.

Start coring @ approximately 9650 feet. Run electric log to total depth, drill-stem test pay zone. Perforate 5 1/2" casing opposite pay zone.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
