**The 7" OD N-80 casing was cemented at 9611 ft. Total depth of hole 9614 ft. Drilled out to 9606 ft. Tested the 7" OD casing to 1200 psi for 30 minutes with light watery mud; no loss in pressure.**

**Preparing to perforate casing, run 2 1/2" BUE with Guiberson Packer and test zone from 9593 to 9600 ft.**
