FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Total depth of 8 3/4" hole is 9614 ft. Cored pay from 9594 to 9599.5 ft. Ran HCNCO caliper survey for cement volume of open hole from total depth back up to base of 9 5/8" casing cemented at 4466 ft.

Plan to run 5500 or more feet of 7" CD 26 & 29 1/2 N-80 new casing cementing same about 9611 ft. This should bring the 7" CD casing some 390 feet up into the 9 5/8" casing. Will cement with 1950 sack 4 1/2 gal cement and 100 sack of neat. If there is any doubt about cement between the strings, will run HCNCO temperature survey to catch top of cement; if no cement between the strings, will then set retainer above 7" CD and make squeeze of 200 sack or more between the 7" and 9 5/8". There is a porous zone below the base of the 9 5/8" casing which will not stand too much pressure or squeezing.
