4. Tag cmt top w/ tbg; pick up 15'.
5. Pump 300 sacks class C neat cmt.
6. RIH w/ CIBP; set in 8-5/8 csg @ 2000'.
7. RIH w/ tbg and fill 8-5/8 csg w/ approx 550 sx class C neat.
8. Tie on to annulus between 8-5/8 and 13-3/8, and pump approx. 300 sx of class C neat cmt.
9. Cut off 8-5/8" & 13-5/8" 2' from surface & erect P & A marker.
