Cement Plugs were cleaned out to 5200 feet. Zone 5000-5040 was acidized under packer/2000 gals. Well swabbed 100% salt water. It is our intention to re-plug this well as follows: A 25 sack plug will be placed at 4970'-5050', a 20 sack plug will be placed at 4300'-4360', a 10 sack plug will be placed in bottom of 8 5/8" surface casing at 4344'. A 6'4" marker with cap and identification will be placed at surface. Location will be cleaned, Pits filled and all junk & debris hauled away.
