To increase Production we propose to do the following work:

1. Set drillable cement retainer at 10,500' and squeeze perforations from 10,570' to 10,595' with 100 sq. of cement.
2. Drill out cement to 10,585.
3. Perforate casing from 10,570' to 10,580'.
4. Acidize perforations with 500 gallons of 15% LST acid.
5. Swab, test, and return well to production.
