Commence plugging the above listed well in April, 1969, as follows: Circulate 9.5# brine gel fluid from 2850' total depth to surface. Spot cement plugs as follows:

- 25 sacks from 2250' - 2320' - base of salt section, open hole.
- 25 sacks from 1840' - 1910' - top of salt section, open hole.
- 25 sacks from 380' - 450' - bottom of 8 5/8" casing.
- 10 sacks from 0' - 30' - top of 8 5/8" casing.
- 1 - 4" well marker and 8 5/8" cap.
