Spud 17 1/2" hole at 2:00 P.M., 4-22-67 and drilled to 375'. Ran 12 joints 13 3/8" OD 48# H-40 ST&C casing with 3 centralizers, shoe and insert float and set at 375' with 350 sax Class "A" 4% cement with 2% CaCl₂; circulated to surface; plug down at 2:15 A.M., 4-23-67. WOC 18 hours. Pressure test 13 3/8" OD casing to 1000 psi for 30 minutes; no drop in pressure. Drilled out cement and float; started drilling 11" hole in new formation at 10 P.M., 4-23-67.
