Ran 130 jts 8 5/8" casing to 4055', cemented with 400 sax cement. WOC 18 hrs. Tested at 1000# psi for 30 minutes. Tested O.K.
Ran 308 jts 5 1/2" casing to 9950', cemented with 200 sax Class "A" plus 8% gel plus 10# salt per sax, followed by 200 sax Class "A" plus 2% gel and 10# salt per sax. WOC 24 hrs. Tested at 1000# psi for 30 minutes. Tested O.K.
