 8/10/67: \*Set cement plugs in the well as follows:  
     25 sx 50-50 Incor Pozmix plus 2% gel from 9150' to 9070'  
     25 sx 50-50 Incor Pozmix plus 2% gel from 8500' to 8420'  
     25 sx 50-50 Incor Pozmix plus 2% gel from 7300' to 7220'  
     50 sx 50-50 Incor Pozmix plus 2% gel from 4580' to 4477' (Excess cement reversed out)  
 8/10/67: Cemented 4-1/2" OD 10.5# casing @ 4477' w/275 sx 50-50 Incor Pozmix plus 4% gel and 7#/sx salt.. Top cement by temperature survey @ 3410'.  
 8/11/67: Tested casing to 4000 psi.  
 8/11/67: Preparing to complete well as a San Andres producer from 4305' to 4340'.
