 2-5-68 Drilled 11" hole to 3820'. Cemented 8 5/8" OD, 24 & 28# casing @ 3820' W/ 400 sx. cement. Plug down @ 10AM.
 2-6-68 W. O. C. 36 hrs. Pressure tested 8 5/8" OD casing to 1000PSI - OK. Started drilling 7 7/8" hole.



