Cemented 8 5/8" 24# & 32# J-55 casing at 3730 with 200 sacks 50/50 Incor Pemmix, 2% gel, 2% calcium chloride. Plug down 3:00 PM 3/5/68. WOC 18 hours and test with 1,000# for 30 minutes, test O.K.
