Drilled 11" hole to 4060', where 8 5/8", 24# and 32#, J 55' was set at 4060 and cemented with 600 sacks lite weight, 11 1/4# salt per sack and 200 sacks type "H" w/2% calcium chloride. Pumped plug down at 7:00 A.M., 3-28-68. Tested casing & Blowout preventers to 1000 psig for 30 minutes at 7:00 A.M. 3-29-68. Tested ok. Top of cement at 3010'. Now drilling 7 7/8" hole.
