1st Plug: 12,670' to 12,520' with 50 sacks Incor Neat w/.2 of 1% of CFR-2.

2nd Plug: 9790' to 9690' with 35 sacks Incor Neat w/.2 of 1% CFR-2.

3rd Plug: 7780' to 7705' with 25 sacks Incor Neat w/.2 of 1% CFR-2.

4th Plug: 5675' to 5600' with 25 sacks Incor Neat w/.2 of 1% CFR-2.

5th Plug: 4290' to 4140' iwth 50 sacks Incor Neat w/.2 of 1% CFR-2.
