BTA Oil Producers is hereby applying for the administrative approval to dispose of water in the San Andres zone of its King #1 SWD located 660' north, 1980' east, Section 8, T-9-S, R-36-E, Lea County, New Mexico.

We anticipate disposing from 1 to 5 thousand barrels of producing Pennsylvanian (Bough "C") water per day to the San Andres formation at a depth of approximately 4098 - 5530', with a surface pressure of approximately 400 psi.

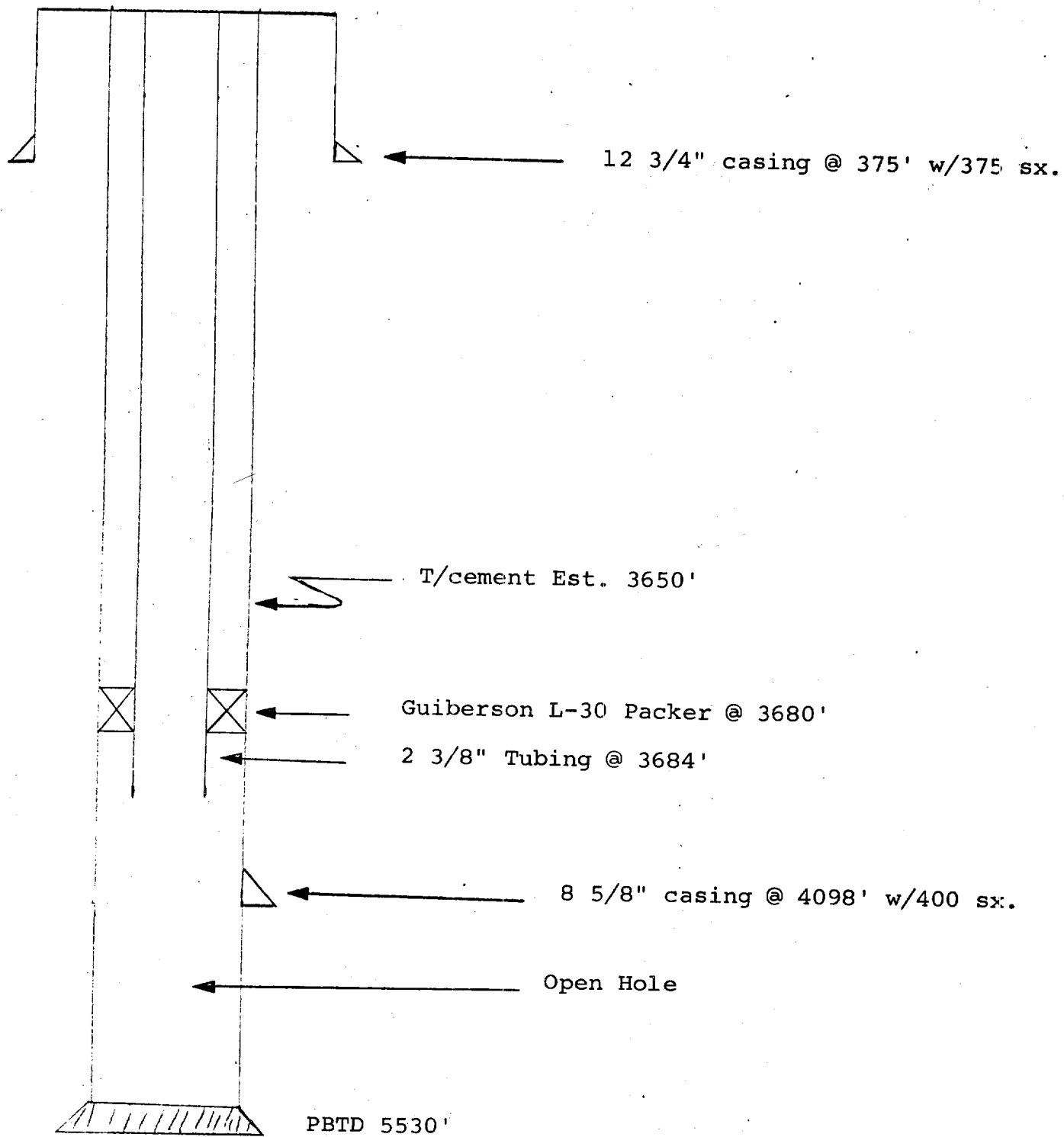

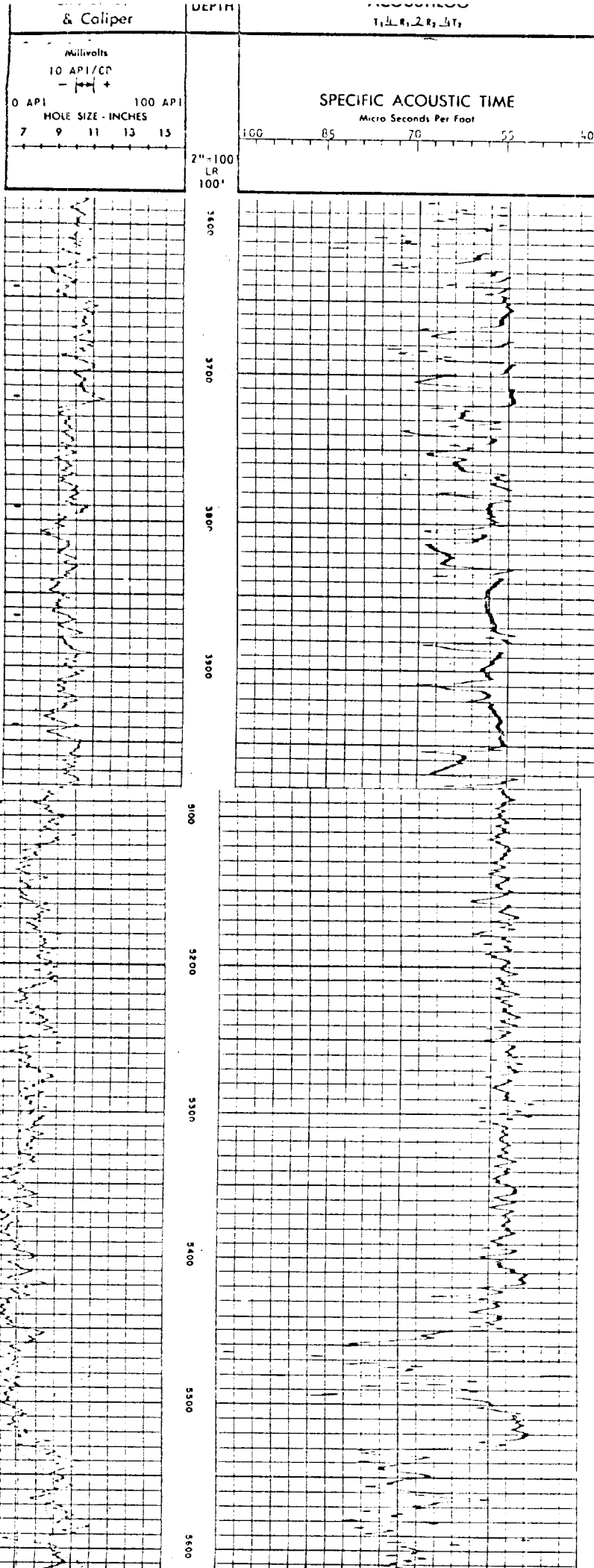
