1. Set cast iron bridge plug @ 4730' and cap w/2 sacks cement.
2. Spot 25 sx. cement from 50' inside 4-1/2" liner to 50' above liner top.
3. Shoot off and pull 8-5/8" casing. Load hole w/10# mud.
4. Spot 75 sx. cement 50' inside 8-5/8 casing to 50' above 8-5/8" casing stub.
5. Spot 75 sx. cement 50' below 13-3/8" casing shoe to 50' above casing shoe.
6. Spot 10 sx. cement at surface.
7. Erect dry hole Marker and clean location.
