2. Displace hole with 1% KCL. Spot 750 gal. Formic acid on bottom.
3. Pull out of hole. Run Correlation log.
4. Perf with .4" holes, 9965, 9963, 9911, 9889, 9879, 9851, 9844, 9823, 9800, 9764, 9737, 9727, 9656, 9652, 9528, 9525, 9509 (17 holes).
5. Acidize with 5000 gal. 15% N.E. acid and sealers.
6. Swab back load and test.
