RUN 8 7/8" CASING AND BRING CEMENT TOP BACK TO 2000'. PRESSURE TEST CASING TO 1000 PSI F/30 MINUTES. AFTER 24 HRS WOC, DRILL 7 7/8" HOLE TO 9950'. RUN 5 1/2" CASING AND BRING CEMENT BACK TO 8600'. TEST CASING TO 1000 PSI AFTER 24 HR. WOC.
