Plug down at 6:45 P.M. MST 8-27-70. Cement circulated. WOC for 9 hours + tested casing with 600# for 30 minutes. Held O.K. mixing temperature 75°F. Estimated compressive strength 1040psi. Formation temperature 64°F.
