11-26-71: Ran 10 jts 8-5/8" casing. Set @ 420'. Cemented with 325 sx Class H with 2% CaCl₂. Plug down at 4:00 a.m. 11-26-71. Cement circulated. Tested to 750 psi. WOC 12 hrs.

Casing was cemented in accordance with NMOCC Option 2 as follows:

1. Volume of slurry - 354 cu. ft., Southwestern, API Class H w/2%.
2. Approximate temperature of slurry - 72° F.
3. Estimated minimum formation temperature - 92° F.
4. Estimated cement strength at time of testing - 1310 psi.
5. Actual time cement in place prior to starting test - 12 hrs.
