Spudded a 17 1/2" hole at 4:00 PM, 9-23-76. Finished hole to 500' at 3:30 AM 9-24-76. Ran 11 joints 12 3/4" OD 49# casing and set at 500'. Cemented w/300 sx Class C Lite w/2% gel followed by 200 sx Class C w/2% CaCl₂. Plugged to 465' at 8:00 AM, 9-24-76. Circulated 30 sx. WOC 12 hrs. Pressure tested to 800 psi for 30 minutes. Held OK. Presently drilling ahead with no problems.
