- Propose to set CIBP @10,870' w/20' cement on top. (Perf. 10,907-10,919'). Top of cement 5100' (Temp. Survey)
- Propose to spot 100' cement plug @Top Wolfcamp (8338').
- Propose to spot 100' cement plug @Top Abo (7240').
- Propose to spot 100' cement plug @5-1/2" Casing Stub (5100').
- Propose to spot 100' cement plug @8-5/8" Casing Shoe (4332').
- Propose to spot 100' cement plug @Base of Salt (2144').
- Propose to spot 100' cement plug @13-3/8" Casing Shoe (406').
- Propose to spot 10' cement plug @Surface w/Marker.
- Hole will be filled w/Mud Laden Fluid.
- Tentative Plugged and Abandon Upon Approval.

Expected Recovery: 5100' of 5-1/2" Casing. All 8-5/8" Cemented to Surface. - *Mc Keown*
