MA, 4' perforated nipple, seating nipple, 1 jt. tbg., Pengo tbg. anchor, & 151 jts. tbg., removed B.O.P., hooked up wellhead, set tbg. anchor with 15,000# tension, final fluid level 1900' down from the surface-released Pool Well Service completion unit.
