Abandoned the above-mentioned well on Feb. 18, 1985 using the procedures as follows.

1. Removed all surface equipment
2. Cement plugs were placed from 5,003 to 4,890 feet and from 2,400 to 2,300 feet. All casings were left in hole.
3. A surface cement plug was placed in the 4½" casing from 50' to surface
4. Mud with density of 9#/gal. was placed between plugs
5. Surface casing was cut off 3 feet from ground level.
6. An abandonment marker as per specifications by the conservation division manual was placed over the well bore.
7. Cleaned up battery location and filled in all pits.
8. A representative from bureau of land management was on site during the abandonment.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
