ABANDONMENT PROCEDURES:

1. Remove All Surface Equipment
2. A cement plug shall be placed from 5,003 to 4,890 feet (perforations were 4,940-5,000' and TD was 5,003'). Casing records are as follows:

Casing Size	Depth Set	Hole Size	Cementing Record	Remarks
8 5/8"	410'	10 3/4"	225 sxs	
4 1/2"	5003'	7 7/8"	1200 sxs	Cement to surface
3. Surface plug of at least 50 feet of cement shall be placed in the 4 1/2" casing which extends to the surface. The top of this plug shall be placed as near to the casing cut-off point.
4. Mud shall be placed between plugs and the mud shall have a minimum density of 9#/Gal.
5. The surface casings shall be cut off 3 feet from the ground level.
6. An abandonment marker as per specifications by the conservation division manual shall be placed directly over the well bore.
7. Clean up battery location including filling in of all pits; removing pipe, junk and trash; and performing surface restoration.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
