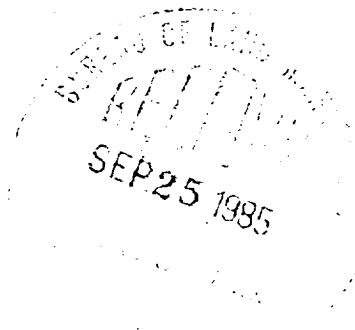

9/22/85 Drilled 12-1/4" hole to 3600'. Received verbal approval from Bob Pitschke at BLM/Carlsbad, NM to set 8-5/8" casing @ 3600' instead of 3760'.
Ran 85 joints, 3609', 8-5/8" 24 & 32# csg; Set and cemented @ 3600' with 1300 sacks Halliburton Lite w/15# salt & 3# gilsonite per sack PLUS 300 sacks Class C w/2% CaCl. Circulated 165 sks to surface. Plug down @ 9:30 a.m. 9/22/85. Pressure up to 1200# for 30 minutes, held OK.
Casing ran: 32 jts - 1374.20' 32# 8-5/8"
50 jts - 2107.78' 24# "
3 jts - 126.02' 32# "
85 jts - 3608.00'
