Drill 12 1/4" hole out of 13 3/8" surface pipe to 4,250'. Set 9 5/8" 36# & 40# J-55 casing to 4216'. Halliburton cemented casing with 1400 sx of Lite Prem cement w/.25#/sx Flocele, 5#/sx salt mixed at 12.4 ppg, 2.06 cuft/sx yield followed by 310 sx C1 "C" w/2% CaCl mixed at 14.8 ppg, 1.34 cuft/sx yield, circulate 207 bbls to surface. Used 8 Halliburton 9 5/8" x 12 1/4" centralizers. PD at 6:35 PM on November 20, 1995. Waiting on completion 8 hours. Test casing shoe to 1000 psi for 15 minutes, reduced to 8 3/4" hole and resumed drilling.
