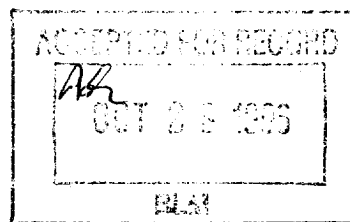

Move in and rig up Ziadril Rig #7. Spud with 17½" surface hole at 10:30 Am, 9/5/96. Drill to 401', Run 13 3/8", H-40, 48# casing and set to 401'. Cement with 390 sacks class "C" cement with 2% CaCl₂. Plug down 9:20 Pm, 9/5/96. Wait on cement for 12 hrs. Run in hole with 12½" bit, test casing to 500 psig for 15 minutes, OK. Drill 12½" hole out of surface pipe.
