Gentlemen:

We have recently drilled our El Zorro G Federal No. 2 well and are currently completing it in the Devonian zone. The lease is currently producing via Well No. 1 which is completed in the Bough C Penn zone and adequate tank battery facilities are in place.

Under the provisions of Rule 309-B, we request authority to commingle production from the El Zorro G Federal Wells No. 1 and No. 2 in the presently existing and operating tank battery facilities.

Commingling will not affect lease stipulations nor the interests of royalty or overriding royalty owners. The attached data sheet, lease plat, and tank battery diagram provide pertinent data.


