TD 470'. Reached TD at 8:30 AM 2-28-97. Ran 11 joints of 8-5/8" 24# J-55 8rd ST&C (472.71') of casing set at 470'. 1-Texas Pattern notched guide shoe set at 470'. Insert float set at 431'. Cemented with 325 sacks Premium Plus with 2% CaCl<sub>2</sub> (yield 1.32, weight 14.8). PD 3:30 PM 2-28-97. Bumped plug to 761 psi, OK. Circulated 85 sacks. WOC. Nippled up and tested to 1000 psi for 30 minutes, OK. Drilled out at 3:30 AM 3-1-97. WOC 12 hours. Reduced hole to 7-7/8". Resumed drilling.
