7/26/97 Test 13 3/8" casing to 500 psig for 30 minutes. Drill 12 1/4" hole out of 13 3/8" surface casing to 4300'. Run 8 5/8" 32# casing to 4300' and cement with Halliburton using 1350 sacks Halliburton Lite with 5#/sack salt and 1/4#/sack Flocele mixed 12.4#/gal, 2.09 cuft/sack. Tail w/300 sacks Class "C" w/2% CaCl₂ mixed at 14.8#/gal, 1.32 cuft/sack. Plug down @ 12:20 AM, 8/3/97.
