1. Drill 12 1/2" hole to 400'. Run and set 400' of 8 5/8" 24# J-55 ST&C casing. Cement with 250 Sx. of Class "C" + 1/4# Flocele/Sx. + 2% CaCl, circulate cement to surface.
2. Drill 7 7/8" hole to 4600'. Run and set 4600' of 5 1/2" 15.5# J-55 ST&C casing. Cement with 300 Sx. of Class "C" cement + additives, estimate top of cement 3100'.
