1. Drill 11" hole to 550' w/ spud mud. Run 8-5/8", 24# csg & cmt w/ 380 sx cmt back to surface. Permit Expires 1 Year From Approval Date Unless Drilling Underway
2. NU 3000# BOP w/ annular preventor. Test BOP, annular, choke manifold, & csg to 1500#.
3. Drill 7-7/8" hole to 5800' w/ native brine. Run 5-1/2", 15.5# csg & cmt w/ 800 sx - est. TOC @ 3000'.
