## DETAILS OF WORK

We propose to drill to a total depth of approximately 9700 feet with rotary tools and complete in the Bough C formation. The casing program will be as follows: 10-3/4 inch H-40 32.75# casing set at 420 feet and cemented with 385 sacks. 7-5/8 inch casing program as follows: Top 3139 of H-40 24.60# & 1100 feet of J-55 26# pipe to be cemented with 450 sacks. 4-1/2 inch casing as follows: Top 100 feet is N80 11.60#. 6300 feet of J-55 11.60# plus 2206 N80 11.60# on bottom to be cemented with 400 sacks.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.


