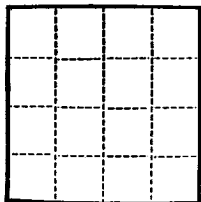

## DETAILS OF WORK

We propose to drill to a total depth of approximately 9700 feet with rotary tools and complete in the tough "G" formation. The casing program will be as follows: 30-2 1/2 inch 30.75% 5-10 surface casing to be set @ 1000 feet and cemented with 400 sacks. Cement will be circulated to surface. 7-5/8 inch 24% 5-55 casing set @ 1000 feet and cemented with 400 sacks cement. 5-1/2 inch 11.6% 5-50 casing set @ 9700 feet and cemented with 400 sacks.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

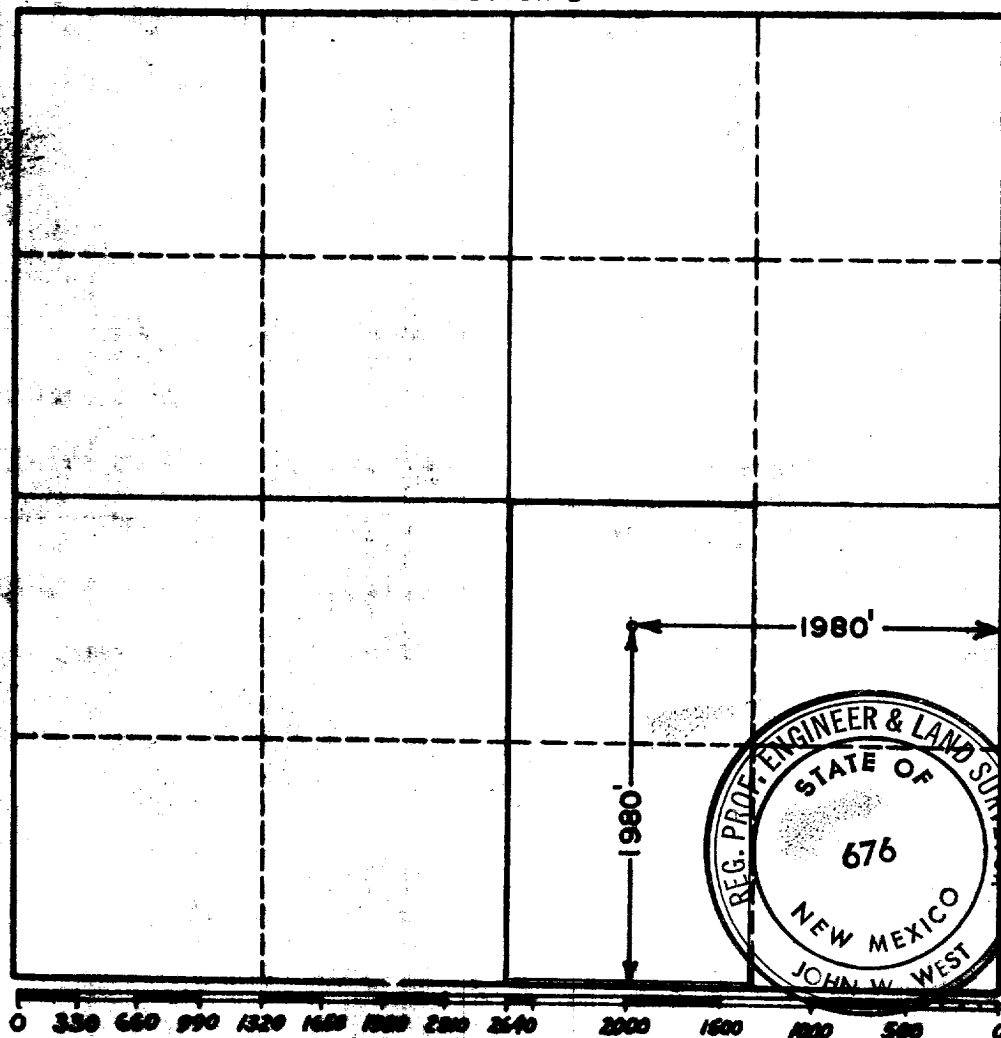
