Laid plug #1 from 5,026' to 4,938' using 25 sacks Portland El Toro cement Neat. Mixed and pumped 15 sacks MilGel with 15 barrels fresh water. Pulled tubing from well bore. Went in hole with McCullough Tool Company jet outter. Cut 4 1/2" O.D. 9.50# J-55 LT&C casing at 3,800'. Came out of hole with casing. Ran tubing back in hole for plug #2. Laid plug #2 from 3,811' to 3,733' using 20 sacks Portland El Toro cement Neat. Mixed 30 sacks MilGel with 30 barrels fresh water and pumped behind cement. Came out of hole with tubing. Laid plug #3 at surface using 10 sacks Portland El Toro cement Neat. Welded cap on 8-5/8" O.D. casing and installed well marker. Pits have been filled and location leveled. The 472' of 13-3/8" O.D. surface casing and 8-5/8" O.D. protective casing set to 4,210' and the 4 1/2" O.D. casing from 3,800' to 5,100' was left in the hole. Notification will be made by letter as soon as location is leveled and debris is picked up so final inspection can be made. Well plugged and abandoned January 30, 1966.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
