Treated down casing in four 5000 gallon stages with 250 gallons acid and 20 ball sealers between stages. Average injection rate 23.1 BPM, maximum pressure 3400#.

7/13/65: Reran rods and tubing, pumping load oil.

7/18/65: Pumped 270 bbls oil, 4 bbls water in 24 hours.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
