Detailed account of work done, nature and quantity of materials used, and results obtained.

Intermediate casing set at 4200'. Used National Seamless 8-5/8" - 24# from surface to 2,650' and 8-5/8" - 32# from 2,650' to 4,200' (all new casing). Cemented with 1,500 sacks of 50-50 port mix (6% gel) and 250 sacks of neat. Cement was allowed to set 36 hours prior to testing. Casing was pressured up to 1,500 psig and shut in. Final casing pressure after 2 hours shut in was 1,495 psig. A five pound drop in casing pressure was recorded during the above test.
