FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Production from this well has declined until it is uneconomical to produce. It is proposed to plug the well as follows:

1. Set 25 sack cement plug in bottom of 4 1/2" casing (perforations 9659-9665').
2. Cut 4 1/2" casing at  $\pm$  8000' and pull.
3. Set 25 sack cement plug in top of cut-off 4 1/2" casing.
4. Set 25 sack cement plug in bottom of 7 5/8" casing at 4120'.
5. Set 10 sack cement plug in top of 7 5/8" casing with marker.

Hole to be filled with mud before setting cement plugs.
