## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

TD 4845'. 8-5/8" Casing set at 309'. Cement circulated. 5-1/2" Casing set at 4600'.  
Top of cement at 3950'.

### PROPOSED PLUGGING PROCEDURE

1. Fill hole full of mud.
2. Plug back with cement from 4845' TD to 4575' (25' above where 5-1/2" casing is set) with 80 sax and squeeze cement.
3. Cut off and pull 3950' of 5-1/2" casing.
4. Plug back with cement from 4000' to 3900' with 30 sax cement.
5. Plug back with cement from 2700' to 2600' with 47 sax cement.
6. Plug back with cement from 2400' to 2300' with 47 sax cement.
7. Plug back with cement from 334' to 284' with 20 sax cement.
8. Plug back with cement from 50' to surface with 16 sax cement and set 4" marker 4' above ground level.
