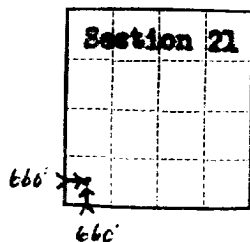

 Casing program to be 13-3/8" new 48# Grade H-40 surface pipe at 400 feet, cement with 250 sacks (circulate); 9-5/8" O.D. protective casing 36# at 4,330 feet, cement with 1700 sacks, 7" O.D. or 5 1/2" at T.D. 9,850 feet, cement with 500 sacks.  
 Hole size to be 17 1/2" to 400 feet, 12 1/2" to 4,330 feet, 8-3/4" to T.D.
