March 21, 1967, pulled rods and tubing. Removed Baker tubing anchor, seating nipple and mud anchor. Checked top of plug at 4,985' with tubing. March 22, ran Tracer Survey to locate where fluid was coming in bore of hole. Showed small amount of fluid going out of hole at 4,878'-90', possible casing collar leak. No indication of channeling up. There is indication there is a channel down to 4,895'. 22% fluid was going out at 4,925' with no channeling up or down. The greater part of fluid being pumped is going out between 4,965' and 4,973' with small amount going down to 4,978' or 5' below lower perforations. Set RTTS tool at 4,862'. Mixed and pumped 100 sacks Lone Star Incon Heat cement. Perforations squeezed to 4000# with 92 sacks out below tool. Jet perforated 4 holes at 4,850' to block squeeze. Mixed and pumped 100 sacks Lone Star Incon Heat cement. Perforations squeezed with 90 sacks in formation to 4000#. Drilled cement from 4,800' to 4,985'. March 25, reperforated 7" OD casing from 4,959'-73', 1 hole per foot, 14 holes. Set Baker full bore retainer at 4,932' with 42' of tail pipe run below retainer. Acidised perforations 4,959'-73' with 2,000 gallons 28% Super X Acid. Pulled retainer out of hole. Ran 2-3/8" OD J-55 EUE tubing with mud anchor, seating nipple and Bedge Model B tubing anchor. March 26, ran pump and rods and put well to pumping. Well pumped 31 barrels water per day with good show oil and gas after load water was recovered. Pumping test ended April 7, 1967, from perforations 4,959'-73'.
